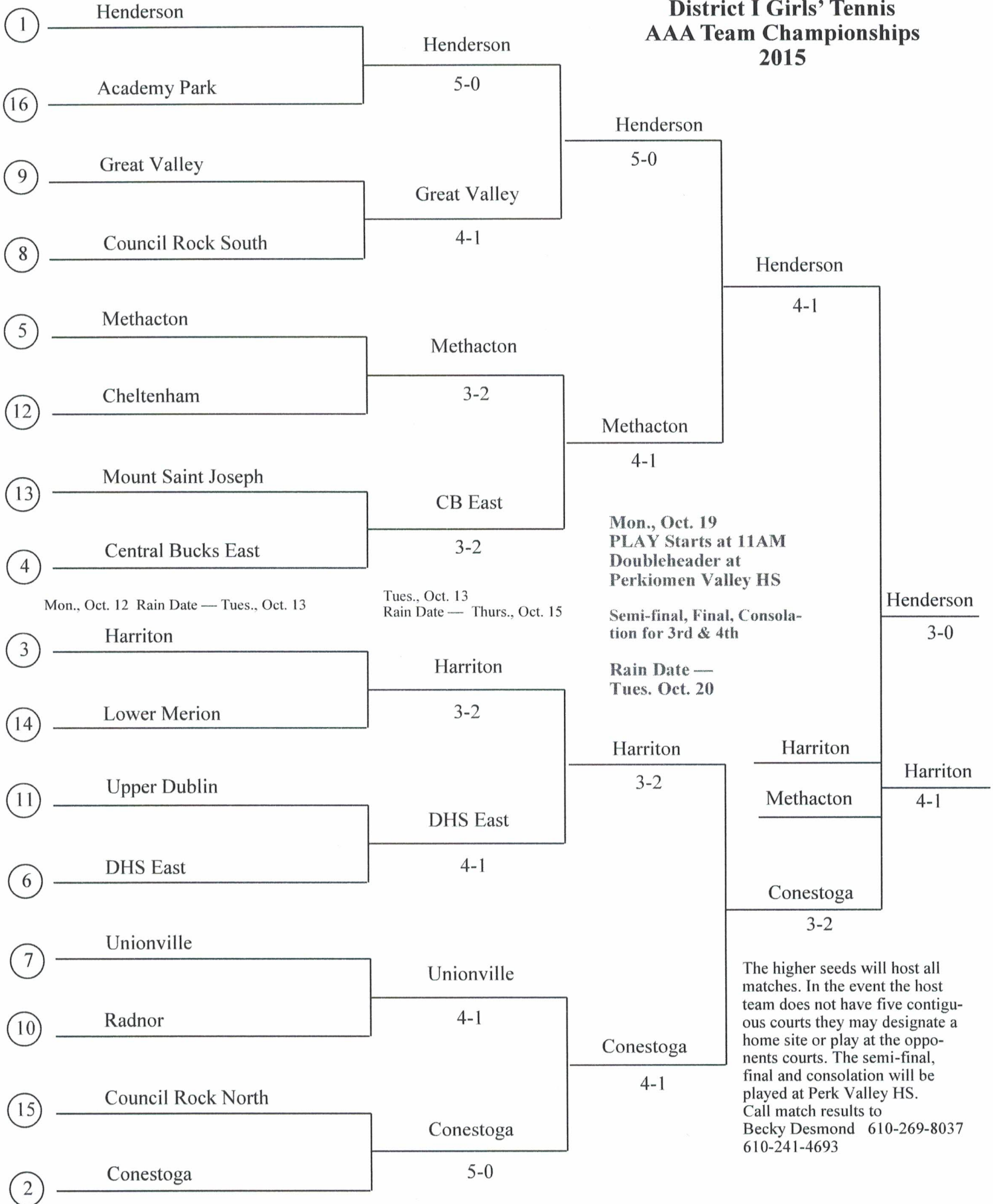

District I Girls' Tennis AA Doubles Championships 2015



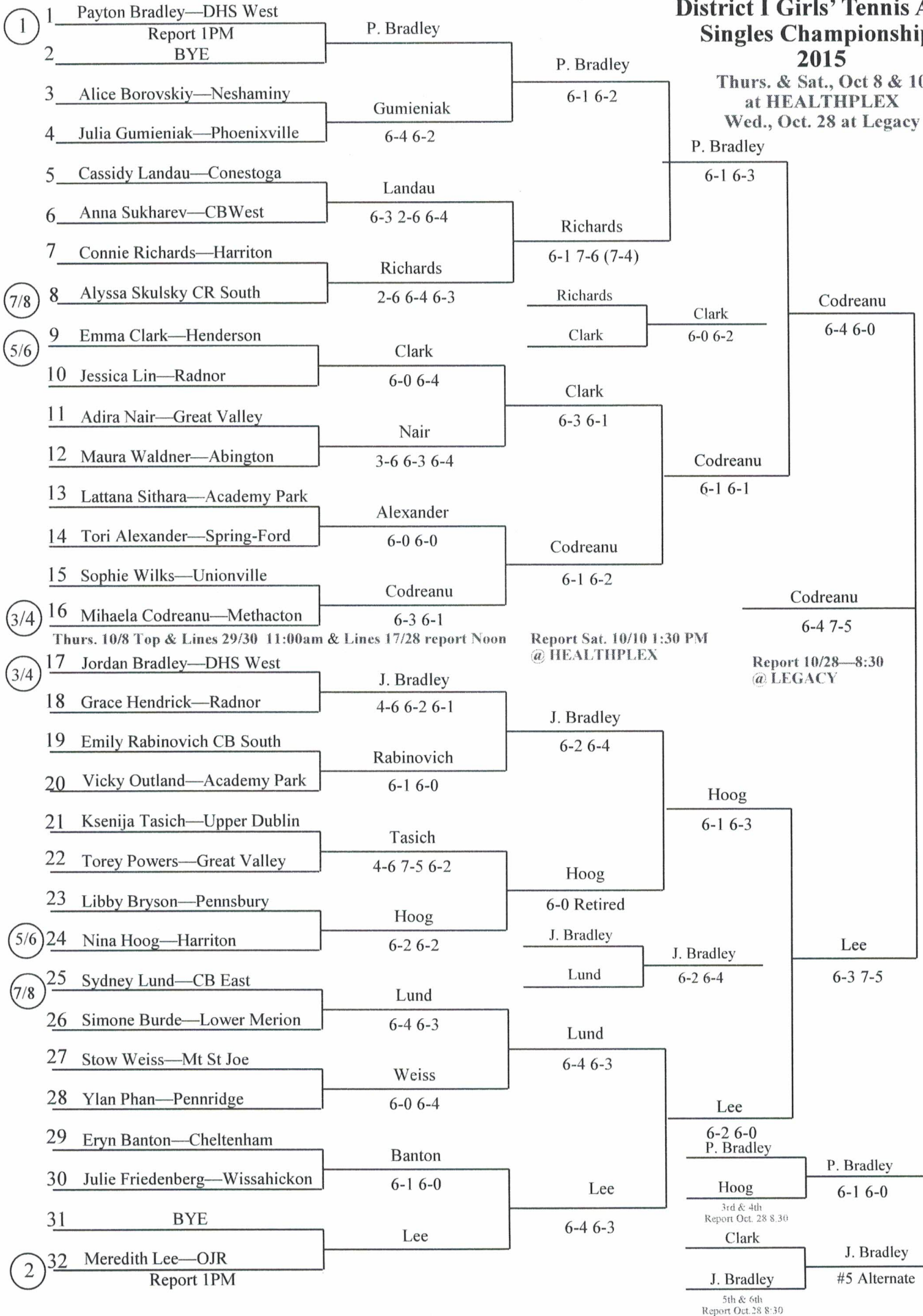
